

Absentee Voting Information

If you or someone you know who lives within the Spring Valley School District and needs to vote by absentee ballot, here is a link that will provide all the information for absentee voting:

But, if you want quick steps for "**registered voters**":

1. A **written request** for an absentee ballot must be made to your municipal clerk. This can be by mail (time is running out) or by e-mail.
2. Once the ballot has been completed using instructions that will come with the ballot, the ballot must be returned to your municipal clerk's office and received no later than 8 pm on April 2nd.

Some of the municipal clerks have In-person absentee voting, but you will need to contact them to determine if they provide the service and the times.
