Maintenance Supervisor

The School District of Spring Valley is seeking a Buildings and Grounds Supervisor. This is a full-time, year-round position to start in June 2024.

Starting pay is negotiable based on experience and credentials. Benefits include health, dental, and vision insurance, health savings account, long-term disability insurance, eleven paid holidays, sick and personal leave, vacation, Wisconsin Retirement System, and up to \$2,000 employer match for 403(b).

Qualifications:

- High school diploma or equivalent
- General knowledge of plumbing, electrical, and HVAC
- Must be physically able to climb ladders, bend, and lift of up to 50 pounds at a time

Duties include but are not limited to:

- Perform all custodial and maintenance tasks on a daily basis along with the custodial maintenance team.
- Must occasionally be available to work on weekends and holidays to respond to urgent needs.
- Assess building systems, pool facilities, grounds, and equipment for needed repairs and maintenance.
- Assign and supervise crews of craftspeople for maintenance work such as replacing wiring, switches, faucets, plumbing fixtures, and repairing fencing, asphalt, concrete, ceilings, and the like.
- Order materials as needed, and make recommendations of supplies and equipment for purchase.
- Regulate heat, ventilation, and air conditioning systems to provide temperatures appropriate to the season.
- Train, schedule, and oversee all custodial maintenance staff to maintain a high standard of safety, cleanliness, and efficiency.
